### **1. President's Report**

## **3. General Business:**

### **3a. Discussion on the setting of membership fees.**

It was agreed to keep the membership fees for individuals as \$20, and unwaged individuals as \$15.

A Family membership was discussed and a figure of \$40 per family with any number of children was proposed. Erin Moody moved to accept that proposal and Kerry Hawkins seconded that motion.

Erin Moody raised the possibility of lifetime memberships and gift memberships. Discussion followed, with the treasurer highlighting that ongoing costs for insurance are \$400 per year. No motion was put forward on lifetime memberships.

### **3b. Discussion on the choice of a GFCG logo from a series of prepared graphic designs.**

A lengthy discussion was had on the choice of GFCC logo from 11 pre-prepared graphic designs by local graphic artist Louise Thorpe. Everyone at the meeting had an input and a process of elimination resulted in the consensus choice of number 8 on the sheet. Kerry Hawkins carried the consensus. The Secretary will write a letter of thanks to Louise Thorpe for her help.

### **3c. Any other business.**

Selene Moonbeams has made contact with the Industries Coordinator at Woorooloo Prison in regards help with structure building at the garden.

ElizabethArcher promoted Transition Town Guildford, their monthly meetings and her once a month Kitchen Garden Society. All are welcome.

An anonymous donation of \$50 was passed to the Treasurer.
